## **Your Obligations:**

- 1. Pay all dues on time. Dues payments are past due on the 15<sup>th</sup> of the month and will be assessed a \$25.00 late fee). Any incurred fees due to declined cards/accounts will be charged back to the swimmer's account. Swimmers are not allowed to practice or attend meets if accounts are delinquent. Dues are payable whether or not your swimmer completes the swim year. The swim year is from September through the following July.
- 2. Only at the sole discretion of the Board of Directors may dues be waived in case of illness or special circumstances where it is impossible for the swimmer to participate in the program. Exceptions need to be formally requested to the board in a timely manner and will be reviewed on a case-by-case basis. Stoppage of practice for more than a month will delay next dues' payment.
- 3. Make sure that your swimmer is at practice and ready to swim on time.
- 4. Say yes to any calls for volunteers. We host two meets per year and conduct various fundraising and special activities that require the support of all the parents. Signing this contract commits your time as a volunteer and at a minimum you must volunteer to work at all Gator sponsored meets.
- 5. Swimmers/Parents will be asked to leave the team if their conduct is disruptive to practice or other operations of the team.
